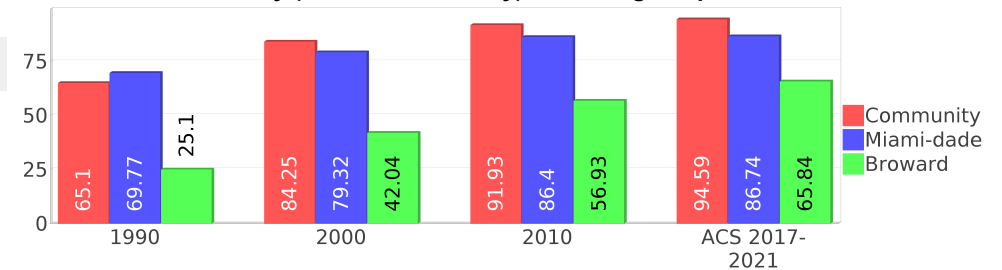

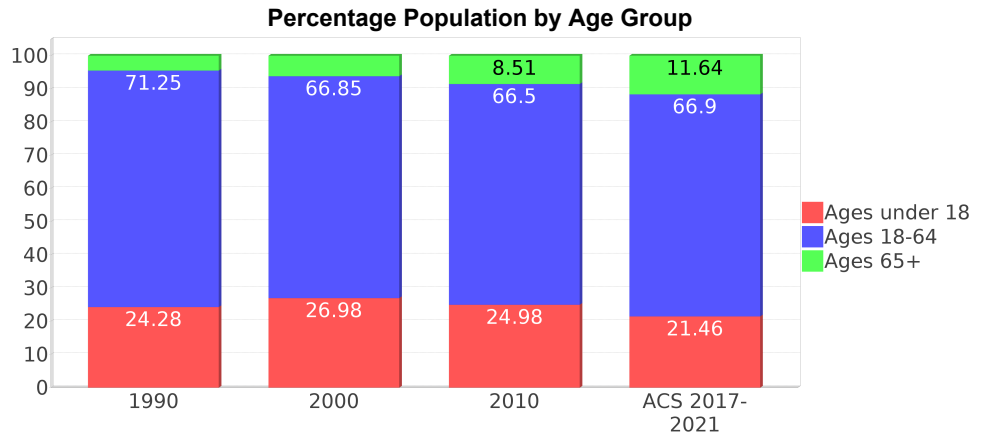


Minority (Race and Ethnicity) Percentage Population



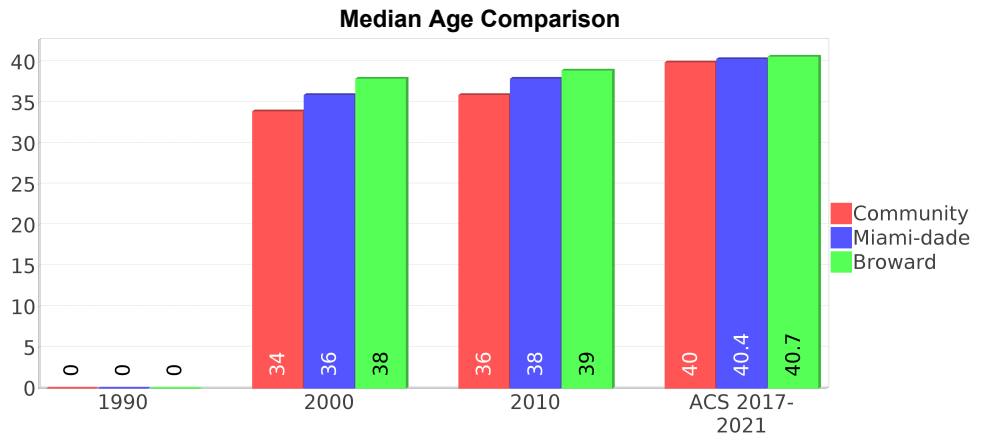

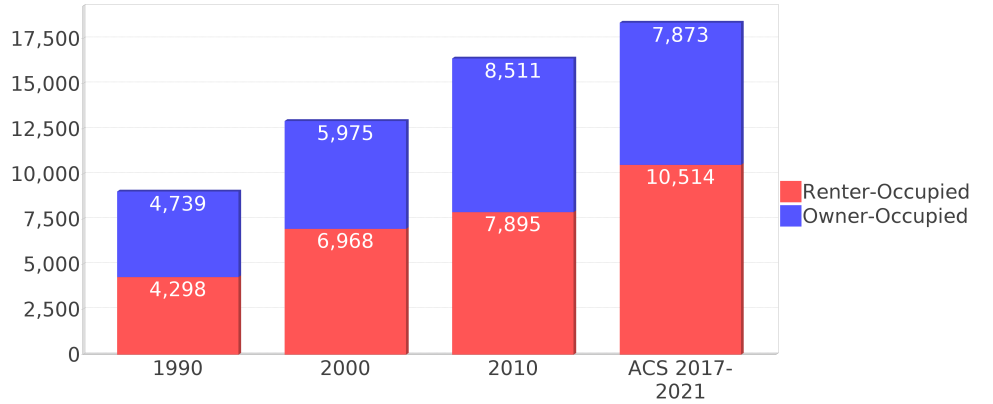

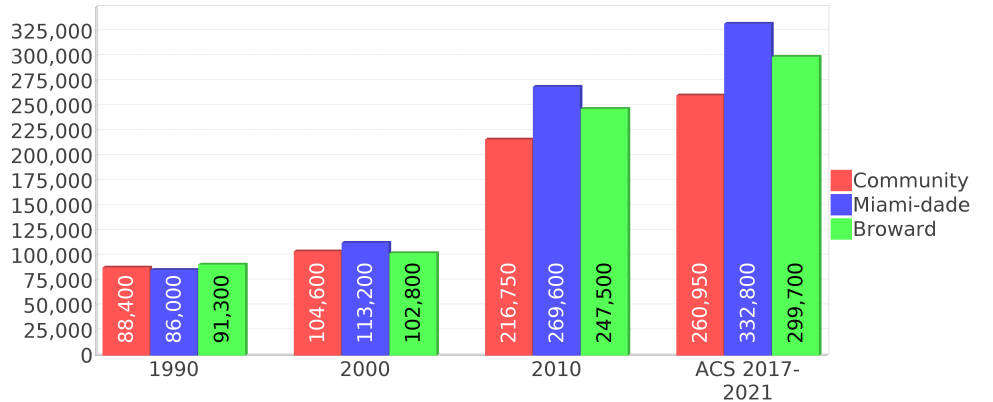

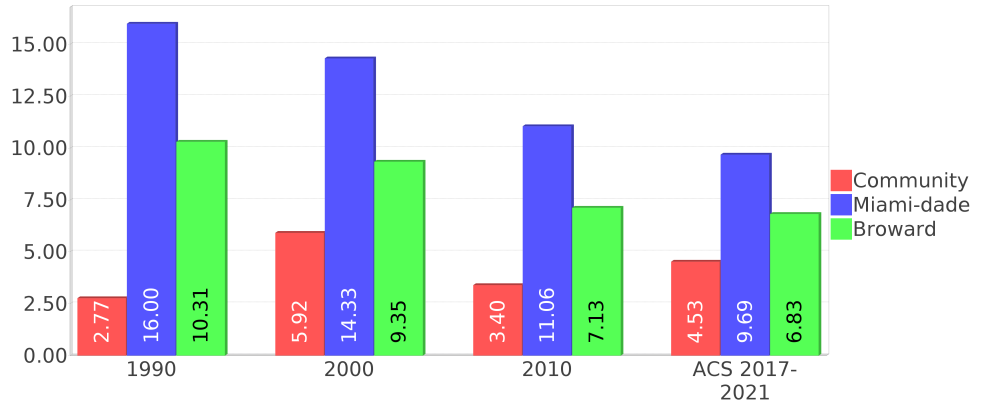
Housing Tenure

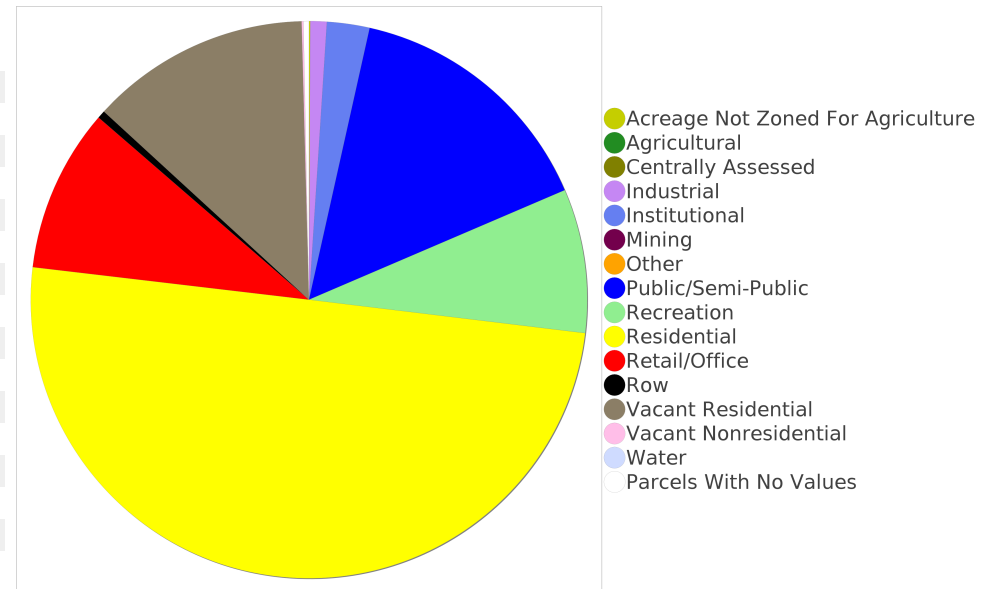

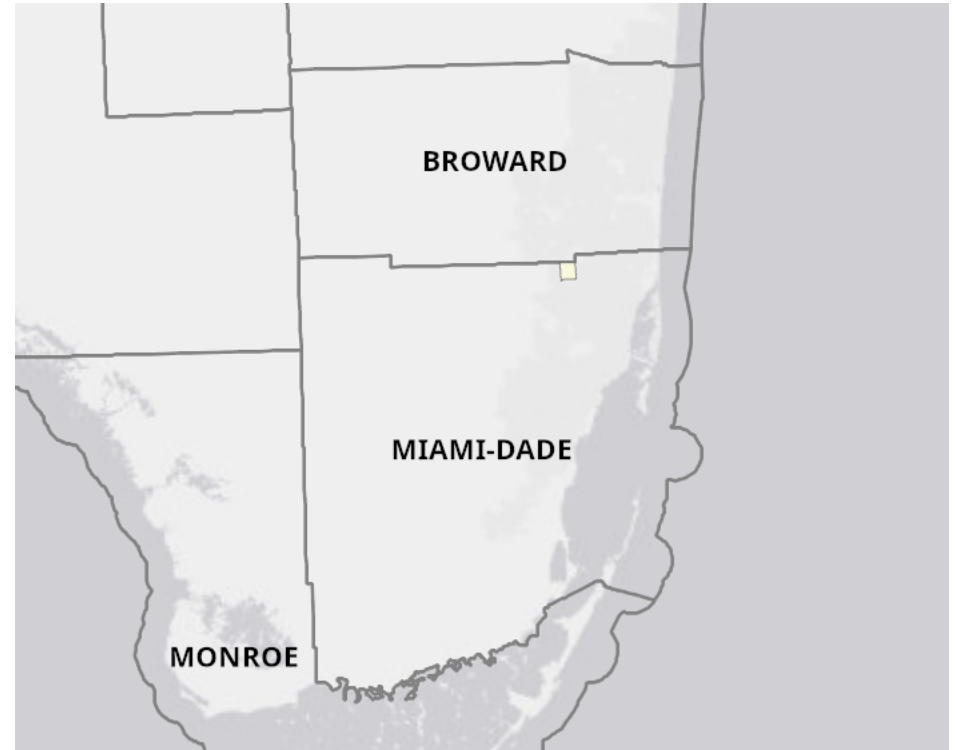

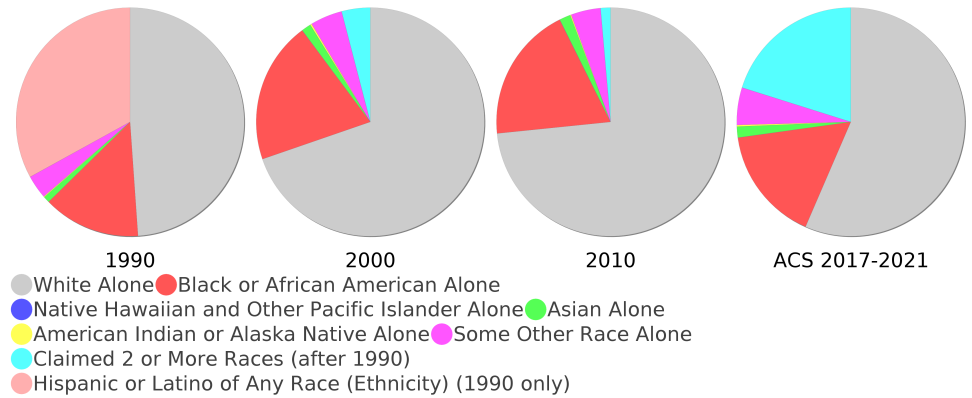

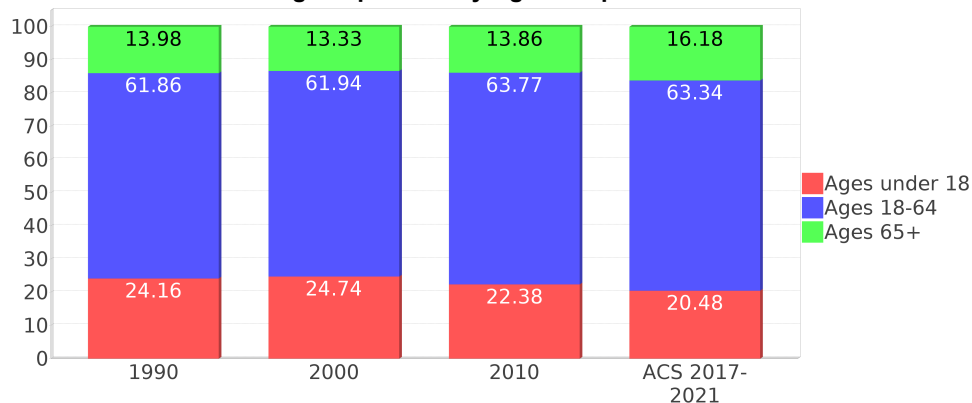

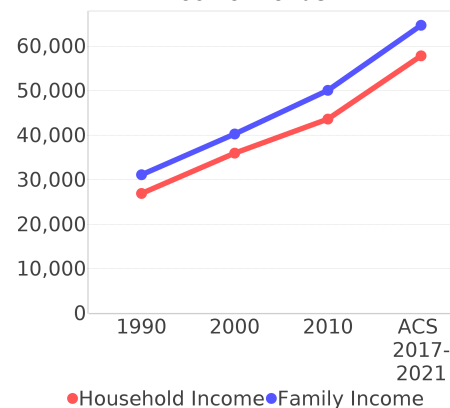
Percentage Population by Age Group - Miami-dade



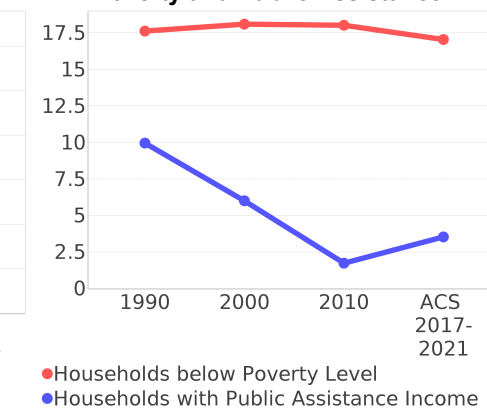

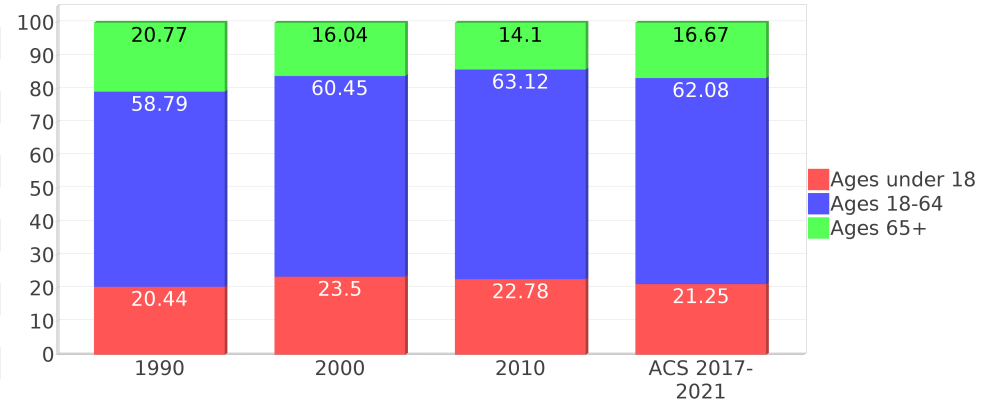

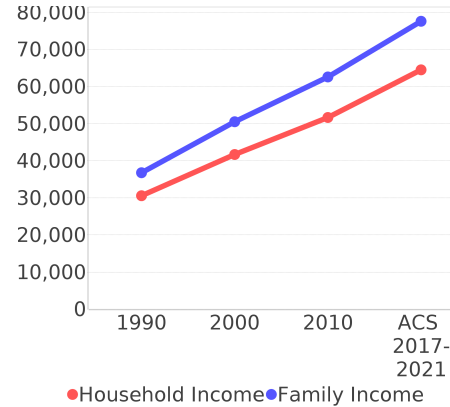
Percentage Population by Age Group - Broward



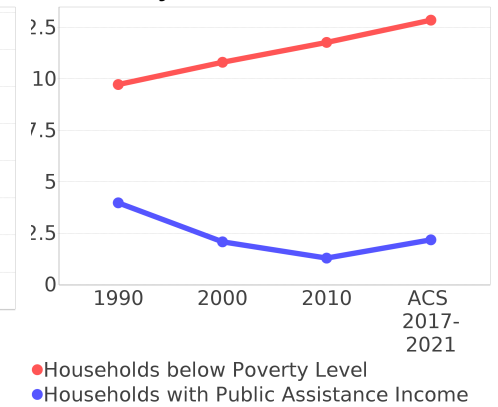

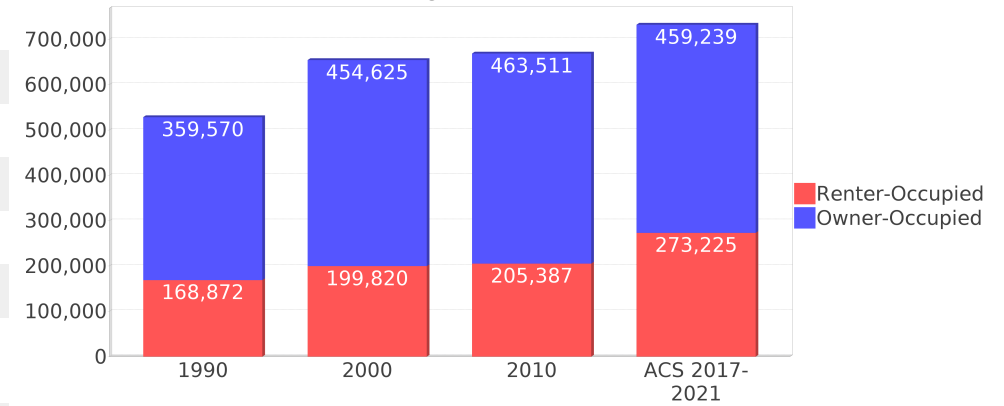
