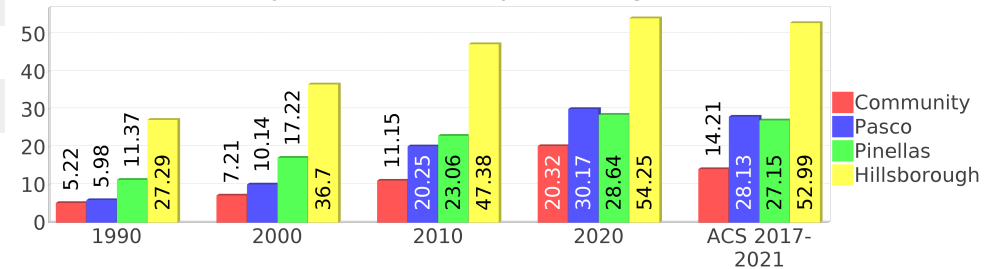

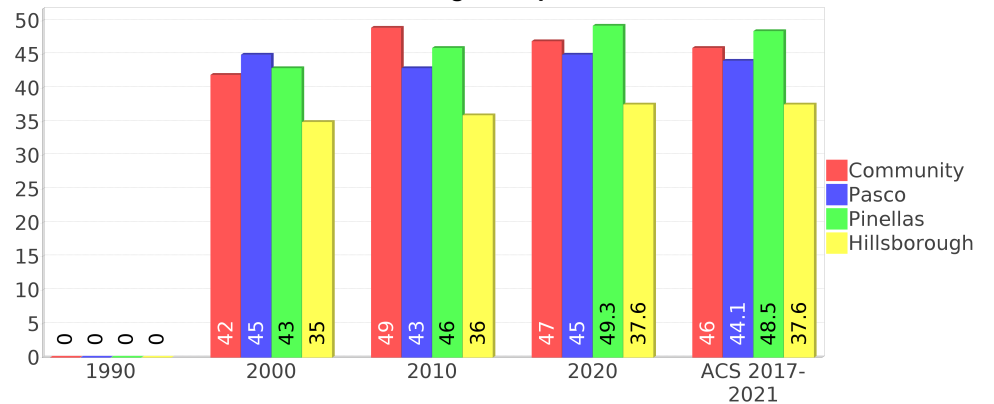

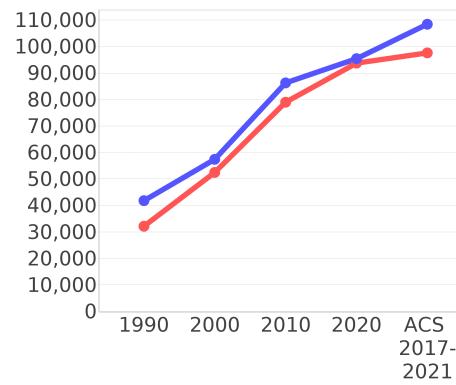
Percentage Population by Age Group



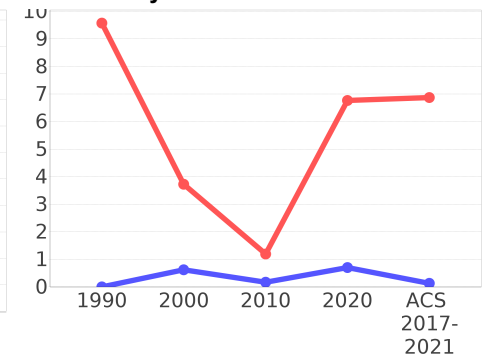

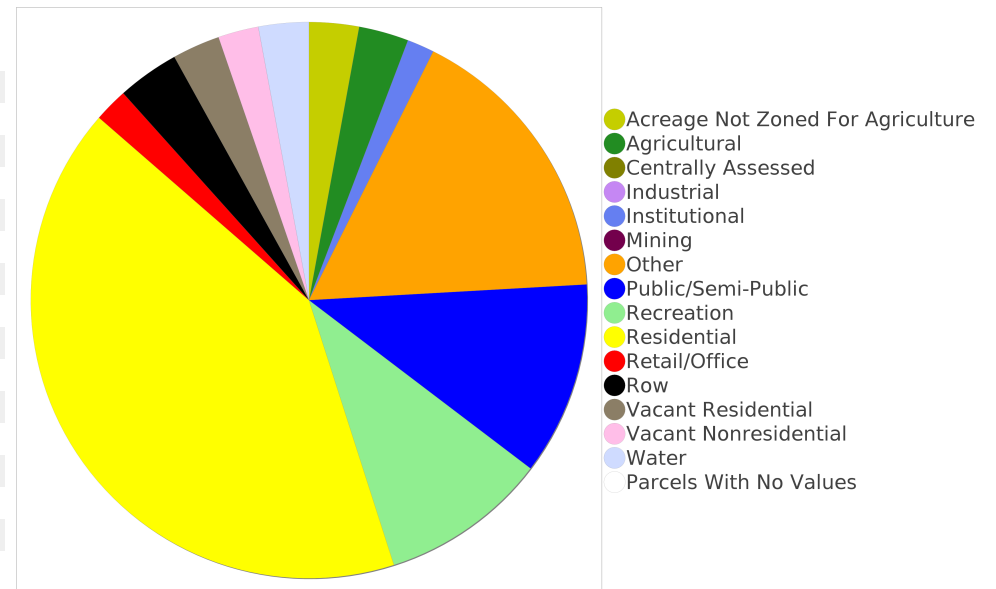

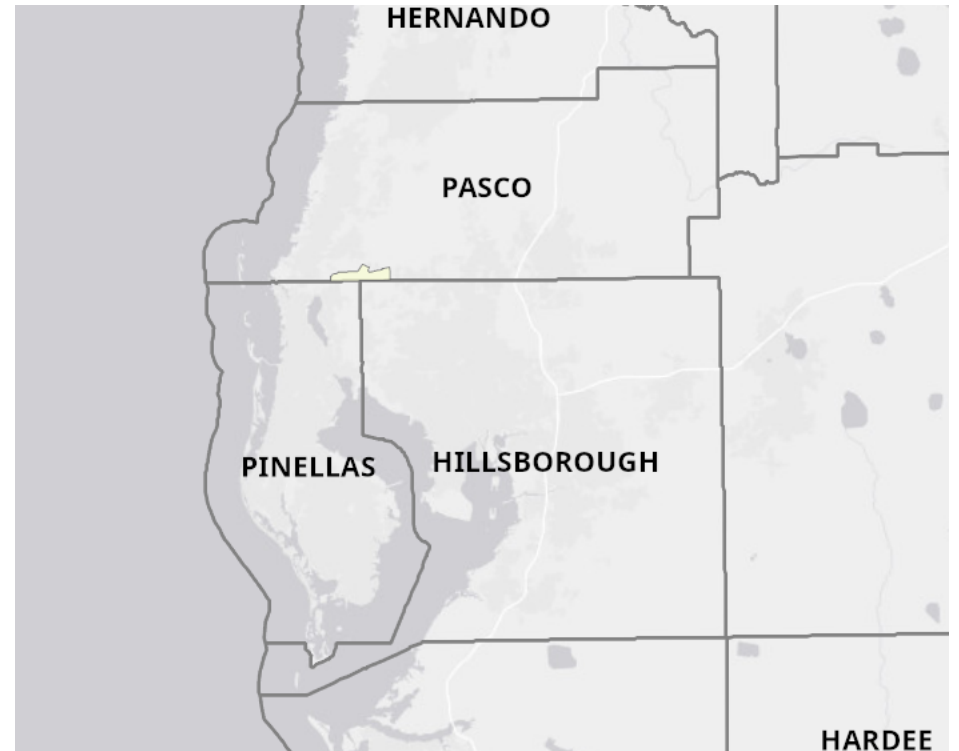

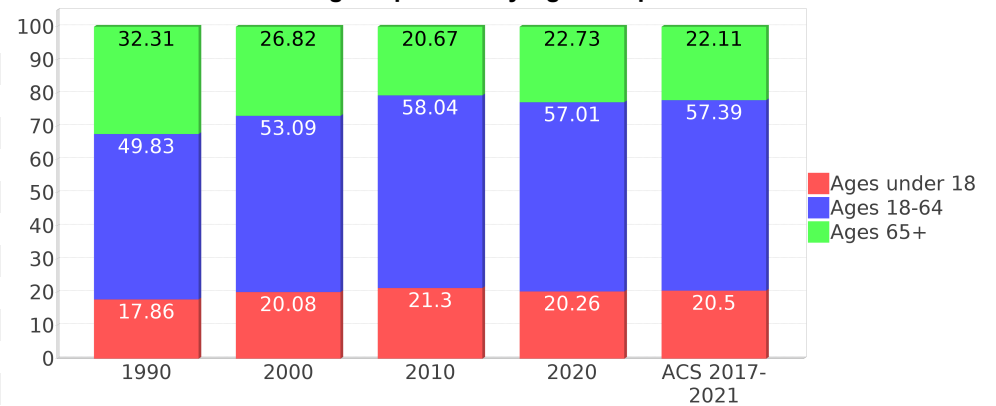

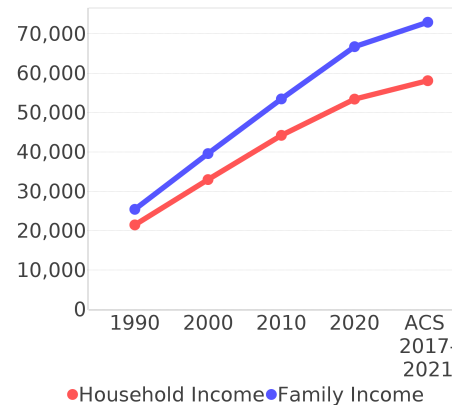
Percentage Population by Age Group - Pasco



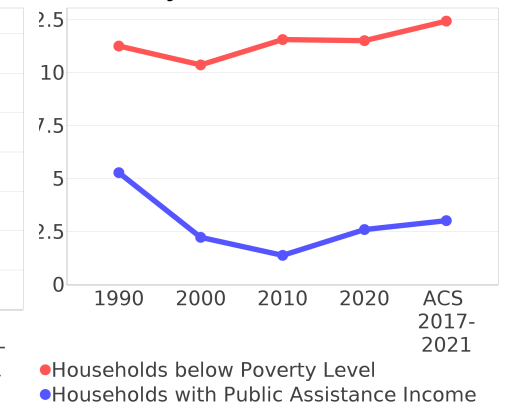

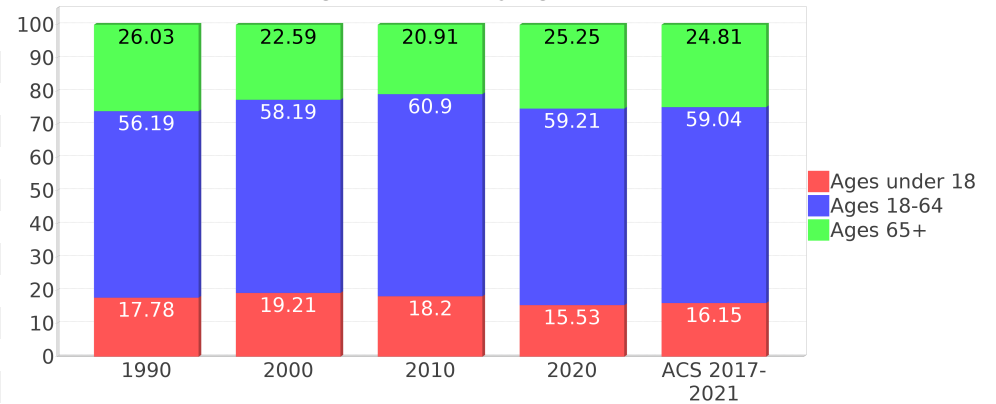

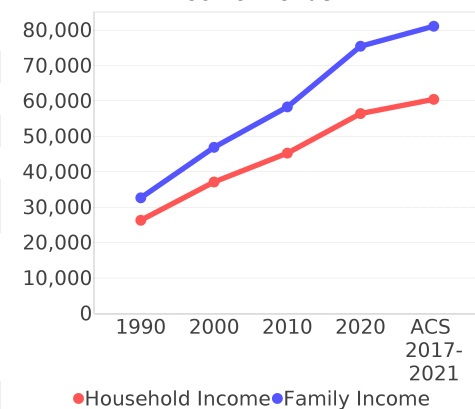
Percentage Population by Age Group - Pinellas



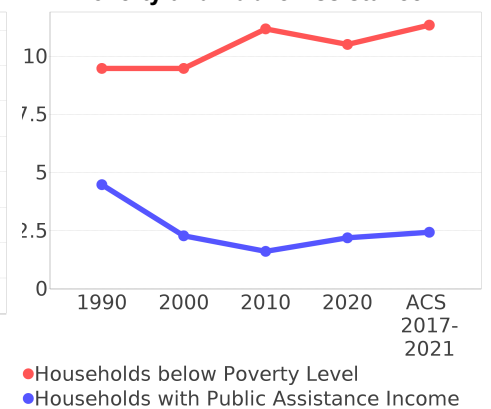

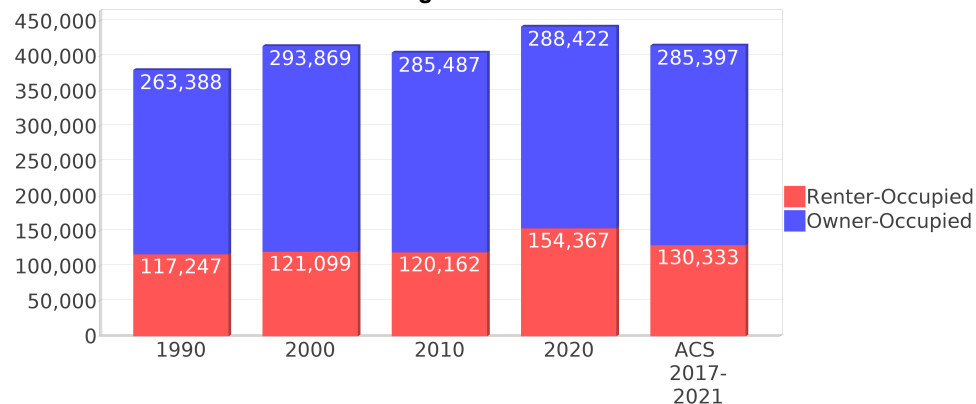

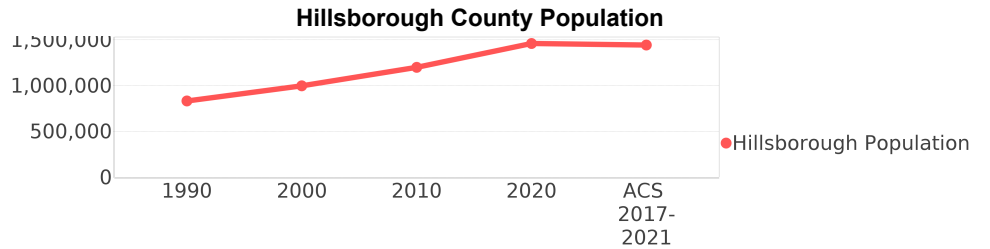

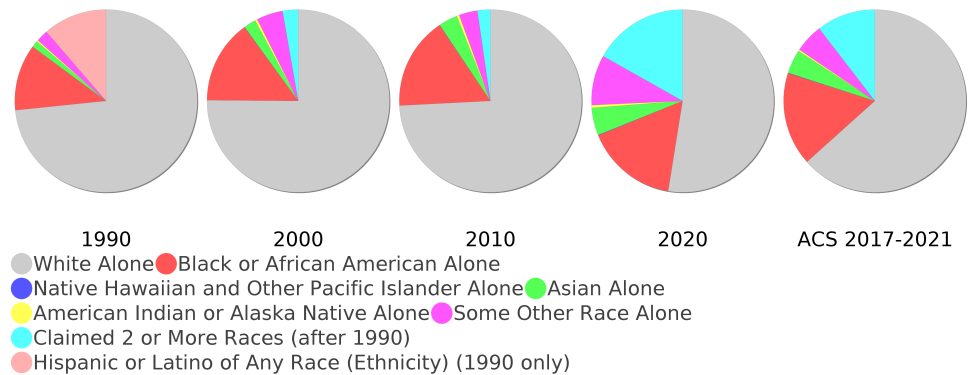

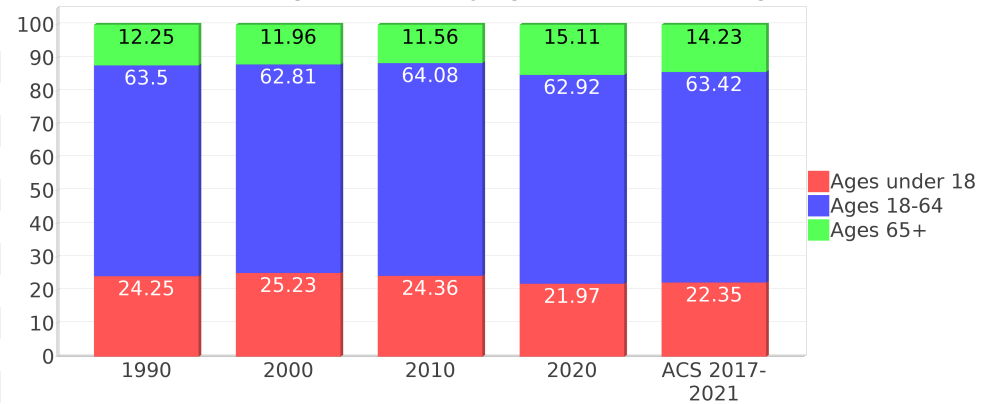

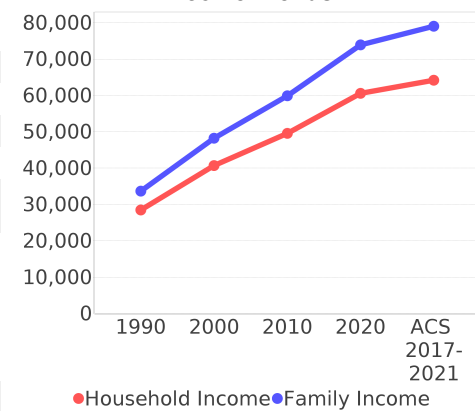
Percentage Population by Age Group - Hillsborough



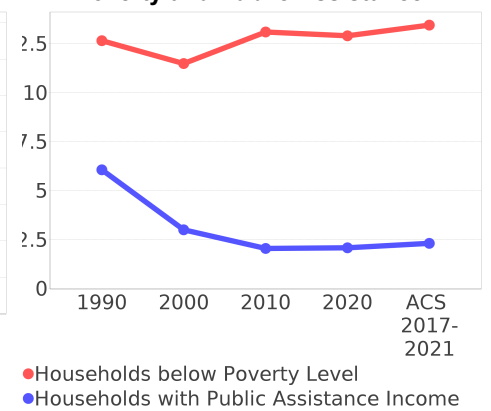

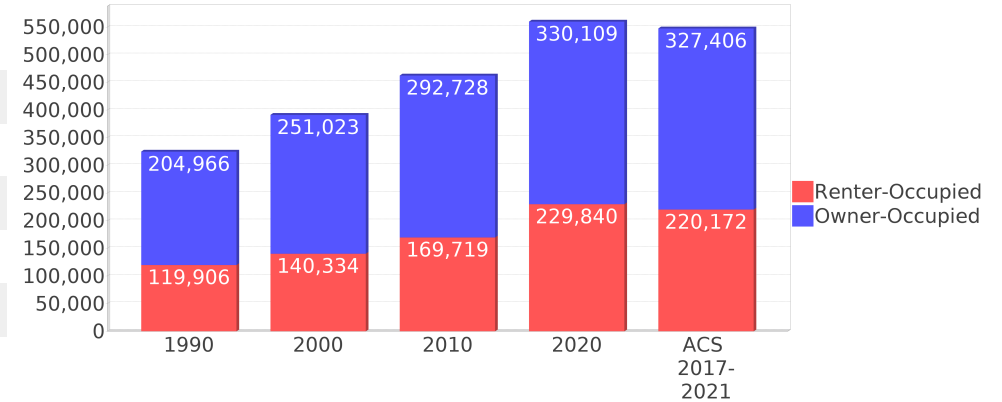
